## Updated retirement guidance, templates and EJRA forms

The EJRA Review Group that conducted the five-year review of the EJRA Policy recommended that further guidance for managers and staff about retirement and alternatives to post-EJRA employment be developed.

In response, a suite of guidance about retirement for use by both staff (at all grades) and managers is now available online and to download. Additionally, an Honorary Research Agreement template and supporting materials are now available, and may be relevant for some retired staff who are seeking to continue their research in a voluntary capacity.

Revised EJRA application forms have been published online. The Spring 2018 and Autumn 2018 timetables for applications are also available online.

A circular issued on 3 October 2017, <u>PERS(17)05</u>, announced the changes to the EJRA that had been confirmed by in votes in Congregation.
